initials In consideration of my being permitted by **Rock Sport Nevada, Inc.**, a Nevada corporation doing business as RockSport Indoor Climbing Center, (herein referred to as "**Rock Sport Nevada**") to climb at its facilities, I agree to the following waiver and release, and I make the following representations.

initials **I acknowledge the inherent extreme risks in rock climbing activities, including those that take place indoors.** I realize that those risks include falls, equipment failure, bad decision-making, inattentive belayers, and holds that have become loose or damaged by other climbers. I understand that there are unforeseeable, freakish accidents, and I assume all risks associated with such accidents, even though I cannot foresee them. I agree to pay attention to the state of the ropes in the gym and that of the anchors, and to advise gym staff if I do any damage or notice any damage. I agree to abide by all gym rules, and if gym staff make a specific request of or instruction to me, I agree to comply.

initials I am physically fit and know of no medical or health reason why I should not participate in the activities that take place at **Rock sport Nevada**.

initials I agree to assume all risk of personal injury, **including paralysis and death**, that may occur while I am in the climbing center or while I am climbing anywhere, at any time. I hereby release **Rock Sport Nevada**, its owners, officers, employees, wall builders, wall designers, hold manufacturers, lessors, insurers, and agents, from all liability for any such personal injury that I may incur. **This release even extends to injuries that may occur through the NEGLIGENCE of Rock Sport Nevada, its employees or other parties released.**

initials I understand that **Rock Sport Nevada** has UIAA approved safety helmets available for use in its climbing center. I acknowledge that wearing a safety helmet could reduce the risk of personal injury that may occur while I am in the climbing center. I assume all risks associated with not wearing a helmet, even though I cannot foresee them.

initials I understand that indoor climbing is not the same as outdoor climbing, and that additional skills are necessary for outdoor climbing that cannot be acquired in an indoor climbing center. I agree to seek qualified instruction before attempting to climb outdoors.

initials This release applies to and binds my personal representative, heirs and my family. If a member of my family under the age of 18 uses the climbing center, I make this release and these representations on his or her behalf as well as my own, and I agree to assume responsibility for his or her safety. Further, I agree to indemnify and hold harmless **Rock Sport Nevada**, and the other parties released, in the event a minor member of my family sues them or any one of them. I understand that this means I will pay all fees, costs, and charges incurred by **Rock Sport Nevada** or any other party released, including attorney fees.
